
### **Emissions reduction targets**

To ensure that progress is made in achieving Net Zero, we have adopted the following carbon reduction target:

• Net Zero by 2040

We anticipate that carbon emissions will decrease over the next five years to 5,389.73 (tCO<sub>2</sub>e) by 2026. This is a reduction of 25%.

Progress against these targets is anticipated to be as in the graph below:



### Carbon reduction projects.

2021 is Acacium Group's first year measuring carbon emissions so no significant carbon reduction projects have been undertaken prior to this. We are in the process of taking further action to achieving our Net Zero target by 2040 which will include a variety of initiatives including:

- Office consolidation
- Further adapting to hybrid working for our staff
- Increasing the number of sites using 100% renewable energy
- Recycling technology at the end of their life cycle
- Improve heating technologies to ensure full optimisation to reduce emissions output

#### Declaration and Sign Off.
